Francis is a member of the Technology Law Cluster in the Singapore Legal Service and has been a legal service officer since 2014. He is also Deputy Director (Policy & Technology) at the Personal Data Protection Commission. In his legal service career, he had prosecuted financial and technology crimes and had advised extensively on contracts, first as Deputy Senior State Counsel at the Attorney-General's Chambers and later as Senior Assistant Director (Legal Services) at the Ministry of Education. He has a Bachelor of Business from the Nanyang Technological University and a Juris Doctor from the Singapore Management University. He was called to the Singapore Bar in 2017.

Mr Yeong Zee Kin holds a Master of Laws from Queen Mary University of London and completed his undergraduate law degree at the National University of Singapore. His experience as a Technology, Media and Telecommunications lawyer spans both the private and public sectors. He has spoken and published in areas relating to electronic evidence and intellectual property, as well as legal issues relating to Blockchain and Al deployment.

Zee Kin is an internationally recognized expert on AI ethics. He spearheaded the development of Singapore's Model AI Governance Framework, which won the UNITU WSIS Prize in 2019. He is currently a member of the OECD Network of Experts on AI (ONE AI). In 2019, he was a member of the AI Group of Experts at the OECD (AIGO), which developed the OECD Principles on AI. These principles have been endorsed by the G20 in 2019. He was also an observer participant at the European Commission's High-Level Expert Group on AI, which fulfilled its mandate in June 2020.

Zee Kin is also a well-regarded expert on data privacy issues. He has contributed to publications on legal issues relating to data privacy and has spoken at many well-recognised international and domestic platforms on this topic.
