

# Intellectual Property (IP) / IP Management Course for Public Agencies

This is a foundation programme recommended for all Civil Servants and Public Officers across Public Service who handle matters involving Intellectual Property (IP) or encounter IP/ IP Management issues in their course of work.

### Avoiding Copyright Infringement for Public Officers

Recommended for Civil Servants and Public Officers who are looking to gain knowledge about government policies around copyright, better understand copyright ownership, types of copyright licenses, common defences / legal exceptions to copyright infringement, managing copyright risks, and how to conduct copyright clearance.

#### Navigating IP Issues in R&D Collaborations

Recommended for Civil Servants and Public Officers who handle matters involving IP in R&D. This course addresses the IPM considerations that arise in R&D collaborations.

#### IP Management in R&D - Understanding NIPP and MRCA

This course focuses on the stewardship of IP development and its usage by public agencies. Public officers will learn to familiarise themselves with the principles of the National IP Protocol (NIPP) and common agreed terms in the Master Research Collaboration Agreement (MRCA).
